MINUTES OF THE EXECUTIVE COUNCIL MEETING PARIS LAS VEGAS HOTEL LAS VEGAS, NEVADA

NOVEMBER 15, 2017

International President Robert Martinez, Jr., called the meeting to order at 9:00 a.m. on November 15, 2017. Executive Council Members Dora Cervantes, Phil Gruber, Sito Pantoja, Mark Blondin, Stan Pickthall, James Conigliaro, Rickey Wallace, Brian Bryant and Robert Scardelletti were present. Executive Council member Gary Allen was present via tele-conference.

APPROVAL OF MINUTES

The Executive Council reviewed the minutes from the October 3-5, 2017, Executive Council Meeting.

After review, a motion was made, seconded, and carried, to approve the minutes from the October 3-5, 2017, Executive Council Meeting.

INTERNATIONAL PRESIDENT'S REPORT

International President Robert Martinez, Jr., advised the Executive Council that a tentative agreement has been reached with the Representatives Association.

International President Martinez updated the Executive Council on the pending sale of the IAM Learjet.

International President Martinez advised the Executive Council on the 2024 IAM Grand Lodge Convention site.

International President Martinez led a discussion with the Executive Council on territory budgets and that he is appreciative of all they have done to reduce their budgets.

International President Martinez advised the Executive Council that the IAM National Pension Plan will be reduced by one trustee.

International President Martinez advised the Executive Council that the Department of Labor has contacted District Lodge 70 regarding their officers' election.

International President Martinez advised the Executive Council that he will be meeting with the Secretary of Labor to discuss the IAM's rerun election.

International President Martinez updated the Executive Council on the campaign at Aerojet in Huntsville, AL. The campaign resulted in a good contract for our members.

International President Martinez updated the Executive Council on "Right to Work" and that General Vice President Phil Gruber is working with the state AFL-CIO to fight RTW.

International President Martinez updated the Executive Council on the National Defense Act. If this passes, it will create thousands of great IAM Union jobs.

International President Martinez updated the Executive Council on the IAM Organizing Director's position.

International President Martinez updated the Executive Council on the Lockheed Martin negotiations.

International President Martinez advised the Executive Council that the IAM is full throttle on Disaster Relief to Puerto Rico.

GENERAL SECRETARY-TREASURER'S REPORT

General Secretary-Treasurer Dora Cervantes reviewed in detail with the Executive Council the end of year budgets for all territories.

General Secretary-Treasurer Cervantes reviewed in detail with the Executive Council the Strike Statement for the period of September 1, 2017 through October 31, 2017.

General Secretary-Treasurer Cervantes reviewed in detail with the Executive Council the Litigation Summary that was prepared by IAM General Counsel Mark Schneider.

General Secretary-Treasurer Cervantes updated the Executive Council on the IAM Free College Benefit that was launched in September and over 133 individuals have enrolled and 150 additional applications have been received. More courses and programs are being developed.

CANADIAN TERRITORY

General Vice President Stan Pickthall updated the Executive Council on servicing and organizing activities within the Canadian Territory.

General Vice President Pickthall updated the Executive Council on the Westjet Campaign.

General Vice President Pickthall advised the Executive Council that the following public sector Unions' staff are looking to the IAM for representation in Vancouver-British Columbia:

- BCNU (British Columbia Nurses' Union)
- HSABC (Health Sciences Association of British Columbia)
- BCGEU (British Columbia Government Employees Union)
- BCTF (British Columbia Teachers' Federation)

General Vice President Pickthall advised the Executive Council that the Canadian Territory currently represents the following two groups of union employees, both labour representatives:

- NSGEU (Nova Scotia Government Employees Union)
- UFCW (United Food and Commercial Workers) Ontario

General Vice President Pickthall advised the Executive Council that TBH (Toronto Baggage Handling) certified with 26 members.

General Vice President Pickthall advised the Executive Council that Sky Café has certified and is in negotiations which could result in possibly 70 new members.

General Vice President Pickthall updated the Executive Council on a raid by CAWU (Canadian Airport Workers Union) on the screeners at Toronto airport.

General Vice President Pickthall advised the Executive Council that the Canadian Staff Conference will be June 20-23, 2018, in Vancouver.

Continue Servicing Donation - District Lodge 11

General Vice President Pickthall led a discussion with the Executive Council on District Lodge 11.

After discussion, a motion was made, seconded and approved, to continue the servicing donation to District Lodge 11 in the amount of \$5,000.00 per month effective January 1, 2018 through December 31, 2018.

GVP Pantoja further advised that an adversary independent union who filed a petition for representation at ExpressJet was dismissed due to insufficient showing of interest. Therefore, that union is barred from filing a representation application for two years.

General Vice President Pantoja advised the Executive Council that Hawaiian Airlines has opened up a brand new state of the art hangar.

General Vice President Pantoja updated the Executive Council on the American Airlines negotiations.

General Vice President Pantoja updated the Executive Council on the JetBlue Campaign.

General Vice President Pantoja updated the Executive Council on the Delta Campaign.

General Vice President Pantoja advised the Executive Council that the IAM filed an Article XXI against the AFA-CWA.

General Vice President Pantoja advised the Executive Council that the Transportation Territory has ratified six railroad agreements this year.
