A Warm Goodbye...

I have been a working stiff for over 50 years and I never really knew what I wanted to be when I grew up. Working for NFFE has come pretty close, though.

When I graduated from UC Berkeley with a degree in English, I thought I would be a poet. In the Master's program in Children's Theater at the University of Hawaii, I was ready to devote my life to educating children through puppetry.

I needed more money than what I was making as a wait person (waitress in those days) at the Wailana Coffee House, so I did a complete U-turn and got a real estate license. From there I moved into construction management and contract administration for multi-million dollar construction jobs and then finally went to law school.

So, what does a person with a BA, ¾ of an MA, a real estate license and a law degree do? The State of California hired me to work at the Public Utilities Commission.

While working for the PUC I got certified as a volunteer neighborhood mediator. One of my fellow mediators who also worked for the State, wooed me from the PUC to the Department of Fair Employment and Housing where I really settled in and found my calling in civil rights enforcement. I stayed there for 18 years—11 as a housing discrimination investigator and 7 as a district administrator before I joined FHEO here at HUD.

How does the Union figure into all of this? I grew up in a union household. My mom was a proud member of the California Federation of Teachers and refused to allow any of her kids cross a picket line. We listened to Woody Guthrie, Pete Seeger, and the Weavers.

In the early 70's, Utah Phillips became my idol and I learned about the Wobblies, the Triangle Shirtwaist Factory Fire, and the San Francisco Dock Strike. I understood the power of collective bargaining and the force of organized labor.

I joined SEIU when I was with the State and then NFFE when I came to work for HUD. Truthfully, though, I paid my dues and that was it...until Dennis Murakami asked me if I would be on the bargaining team to bargain the move from the old San Francisco HUD office to the new oneWhen the bargaining was done, I went back to my FHEO enforcement job and worked there quietly until Liz McDargh asked me if I would be a union steward.

I started working a few hours a pay period for NFFE. Slowly, under the mentorship of Charron Alfonso, Karen McNamara, Jan Thompson and Liz, I learned how to be a steward. I attended six week-long steward trainings at the Machinist's training center in Maryland, and built up my confidence to advocate for bargaining unit employees.

As a NFFE steward, I came to understand HUD as a whole—starting with FHEO and then learning how PIH, CPD, Multi-Family, FPM, BFS, OPM, etc., etc. contribute to making HUD HUD. My HUD contacts increased from my 25 FHEO colleagues to over 400 bargaining unit employees and managers in Region 9.

I've helped employees get reasonable accommodations, hardship transfers, back pay, locality pay, and voluntary leave donations. I helped convince management to waive an \$11,000 debt it insisted on collecting from an employee because of a clerical error.

I've filed numerous grievances for employees disputing performance evaluations, reprimands and contract violations and I've advocated for them in grievance meetings with management.

I have sat with employees in formal mediations and informal meetings with managers to establish respect and better communication.

I was a substitute bargaining team-member for the last Labor Management Agreement and I've been on a number of mid-term bargaining teams bargaining important issues for employees.

NFFE is the only entity that does all of this for non-management employees, and because I know that our strength is in our numbers, I've recruited 38 members.

I've come to love and appreciate nearly everyone I've worked with in every office and especially my NFFE sisters and brothers!!

I thank Dennis and Liz for bringing me in and putting me on the path to one of the most fulfilling things I've ever done.

I'm retiring on August 31st to head off to new and different adventures.

With a tear in my eye, I wish you a warm goodbye. Solidarity forever!!
